President's Report to the Board of Trustees March 20, 2019

### Direct Credit for area Career and Technical Education (CTE) Students

For the third consecutive year, ACC is offering one-credit direct-credit coursework to area Career and Technical Education students. These ACC courses are taught by Higher Learning Commission qualified K-12 CTE instructors on site at regional high schools or tech centers at no cost to ACC. The courses qualify for transfer under the Michigan Transfer Agreement and the students receive one ACC credit upon successful completion of the course. Significantly, attaching direct credit from a community college to K-12 CTE programs allows for enhanced reimbursement from the State under a funding stream called 61B. Over the past two years, approximately \$1.5 million in 61B revenue has come back to regional CTE providers through this direct credit partnership. We value the opportunity to work with these educational partners and hear from them that they appreciate our collaboration on this initiative.

2.736, Revision of Policy 5024, In-State Tuition for Veterans Educational Benefit Recipients, 2nd Reading

Following is the proposed revised policy. Changes are indicated in red.

5024 In-State Tuition for Veterans Educational Benefit Recipients

Any individual using educational assistance under either Chapter 30 (Montgomery GI Bill® -- Active Duty Program), Chapter 31 (Vocational Rehabilitation), Chapter 33 (Post-9/11 GI Bill®) of Title 38, United States Code, Chapter 35 (Survivors' and Dependents' Educational Assistance Program), Chapter 1606 of Title 10 U.S.C. (Montgomery GI Bill – Selected Reserve), and/or the Marine Gunnery Sergeant John David Fry Scholarship (38 U.S.C. §3311(b)(9)) who lives in the State of Michigan while attending Alpena Community College (regardless of his/her formal state of residence) shall be charged no more than in-state tuition.

The Alpena Community College Board of Trustees approves on second reading the proposed revision of Policy 5024, In-State Tuition for Veterans Educational Benefit Recipients.
