2.738 Selection of Construction Management Firm for the Center for Health Sciences Van Lare Hall Renovation Project

In July 2017 the State of Michigan approved Public Act 107 of 2017 which authorized planning for Alpena Community College's proposed Center for Health Sciences. The project would repurpose Van Lare Hall to provide space and updated technology to house an enhanced Nursing program and offer a community gathering space overlooking the Thunder Bay River.

At the October 31, 2017, special meeting, the ACC Board of Trustees approved the selection of Cornerstone Architects of Traverse City, Michigan, to provide architectural services for the design and construction of the Center for Health Sciences.

In December 2017 the Board of Trustees approved the hiring of Oak City Contracting, LLC., of Alpena, Michigan, to be the pre-construction manager for the project.

In late winter 2019 Oak City completed their pre-construction responsibilities and subsequently withdrew from the project. After receiving feedback from state officials on how best to proceed, ACC administrators began discussions with the bidder who received the second highest scoring from the pre-construction manager bid process, Spence Brothers of Traverse City, Michigan.

Representatives from Spence Brothers met with ACC administrators regarding the specifics of the renovation project. Based on those discussions, administrators have revised the project proposal resulting in the following specifications and estimated total project cost of \$8.7 million.

Cost of Construction: \$6,264,000.00

Project Timeline: 14 months

Construction Manager Fee: \$669,616.00

Based on the results of the scoring system, feedback from state officials, and numbers above, ACC administrators are recommending Spence Brothers be approved as the construction manager for the Center for Health Sciences Van Lare Hall renovation project.

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves Spence Brothers of Traverse City, Michigan, as the construction manager for the Center for Health Sciences Van Lare Hall renovation project.
