# 2.748 TRiO Talent Search University Tours Bussing Bids

Alpena Community College's TRiO Talent Search program regularly takes students to visit Michigan universities for tours. This year, TRiO has scheduled trips to eight universities. Large buses are needed to transport the number of participating students on each trip.

A request for proposals was created and circulated to potential bus transportation companies. Two companies responded; following are the results.

The cost of these trips will be covered under TRiO Talent Search's budget.

Business Office and TRiO staff examined the bids and communicated with the vendors to finalize the proposals. The Business Office is recommending the bid by Blue Lakes by the Bay due to their geographical proximity and their bid was the lowest.

## Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approved a contract with Blue Lakes by the Bay of Traverse City, Michigan, for 11 bus trips for the ACC TRiO Talent Search program at a cost not to exceed \$32,149.00. The cost for these trips will be paid from the TRiO Talent Search funds.

## 2.749 Nursing Training Mannequins Bids

In March 2019 Alpena Community College's Nursing Program received approval for a \$12,121 grant from the Michigan Department of Licensing and Regulatory Affairs (LARA) to be used for the purchase of simulation equipment. The money was made available through LARA's Nurse Professional Fund Grant to Approved Nursing Education Programs.

The grant money will have a two-fold impact on ACC's Nursing Program: it provides seed money for the purchase of simulation equipment to be used immediately by ACC Nursing students, and the new purchase will help ACC demonstrate how it plans to modernize the Nursing Program through the Center for Health Sciences project.

After discussion, the Nursing Program decided to use the LARA grant money to purchase a pediatric simulator mannequin.

College officials solicited bids for a pediatric simulation mannequin but had not received full information from one vendor by the deadline for sending out the August Board of Trustees meeting agenda. A full action item will all relevant information will be provided to the trustees as soon as it becomes available.

# 3.967 Financial Report

Monthly General Fund Revenue and Expense through July 2019 (Year to Year Actual Comparison)

- The property tax receipts of \$117,013 are \$32,542 more than those for July 2018. This is due to timing of the collection of taxes.
- Tuition/fee receipts of \$3,057,548 are \$194,087 more primarily due to higher than expected enrollments and an increase in tuition rates.
- State aid for the current year is zero because of the normal start month of October.
- Instruction is less than last year due to two retirements and lower part-time instruction costs.
- OIT is up due to a significant increase in software maintenance costs and timing of information processing costs.
- Instruction Support is up due to salary and fringe benefit increases and timing of payout for retirees.
- Net income through the first month of the new fiscal year shows as a gain of \$1,949,766, which is typical for this time of year, when fall tuition receipts have built up.
