President's Report

President's Report to the Alpena Community College Board of Trustees

September 18, 2019

Fall Enrollment at ACC

According to the most recent MACRAO data, ACC finished first among Michigan's 28 community colleges in enrollment growth, finishing up 4.2% in credit hours and 4.5% in headcount compared to fall semester 2018. Data points of note:

- Early College enrollment increased 31.7% in credit hours, 29% in headcount
- Dual enrollment increased 7.6% in credit hours, 6.5% in headcount
- 5-county service district enrollment increased 13.8% in credit hours, 14.9% in headcount
- Oscoda campus enrollment increased 23% in credit hours, 6.9% in headcount
- VCS course delivery enrollment increased from 24 to 39 sections and 203 to 412 students

Consultation Education and Training (CET) Grant Award

(From Dawn Stone)

Although the State of Michigan has not approved a state budget for Fiscal Year 2020, and therefore no awards can be made at this time, MIOSHA has tentatively approved ACC's Consultation, Education and Training (CET) project for the amount of \$45,000. The purpose of the project is to provide free safety related training to four high-hazard occupations: (a) medical and residential care facilities; (b) construction; (c) manufacturing; and (d) forestry and logging. We plan to provide a Safety Forum which brings MIOSHA staff and business from across the region into a non-punitive, low pressure setting for information and Q&A sessions, OSHA 10 courses, ergonomics and lifting training, asbestos awareness, and presentations on other applicable topics. In addition, we have partnered with Thunder Bay Tree Service and will be offering a boot-camp style safety training in the spring, covering such things as electrical hazard awareness training, aerial rescue, and chainsaw operation. Activities performed with this grant have been successful in the past and we are looking forward to enhancing that trend.

2.750 Computer Lab Rotation Purchase

The Board of Trustees authorizes appropriate College officials to purchase 35 HP mini-tower computers for a cost of \$43,051.05.

Information Items

Vice President for Administration and Finance Richard Sutherland noted he had included more detail in the Financial Report summary based on his conversations with Trustee Stender. He noted tuition revenue for Fall Semester was approximately \$220,000 more than was budgeted. Revenue from state aid had not been set yet due to the extended budget negotiations going on in Lansing. It is possible the College will receive a .8% increase over last year along with an additional small amount related to state equalized tax values.

Board Discussion

Chairman Briggs announced his appointment to a state board had ended and his schedule was open to going back to meeting on Thursday nights. He asked the other trustees and President MacMaster if they wished to change the regular Board of Trustees meeting day.

President MacMaster expressed his opinion that going back to Thursday evenings would help his work weeks. Trustee Townsend also said that going back to meeting Thursday nights would help his work schedule. Trustee Stibitz noted that going back to Thursday nights may create a conflict with some MCCA meetings. Other trustees checked their schedules and were available both Wednesday and Thursday nights.

Chairman Briggs then introduced the topic of the MCCA 2020 Summer Conference, which is scheduled to be held on Mackinac Island July 22-24, 2020. He asked the trustees to consult their schedules to see if they wish to attend the conference. Once it is known how many trustees wish to attend, he suggested that arrangements could be made for ACC trustees to stay together in less expensive accommodations on the island.
