2.768 John M. Grant Front Runner Awards

Alpena Community College's annual end-of-year activities includes a Nurses Pinning ceremony, the Honors Breakfast, and Commencement. This year would have been ACC's 67th Commencement but those events were cancelled due to the COVID-19 pandemic and state restrictions on group gatherings.

A much-anticipated part of the year-end festivities is the presentation of academic awards. These awards recognize our students' academic achievement and celebrate their personal stories of perseverance and accomplishment.

Despite the unusual end to the school year, it is appropriate for the College to recognize some of the many student success stories that have happened this past year, and also to bestow academic honors. In place of Commencement and the Honors Breakfast, the ACC Board of Trustees has agreed to publicly convey the awards.

The first award is the John M. Grant Front Runner Awards, which are usually given annually to a graduating male and female non-traditional student who has demonstrated unusual dedication in the pursuit of higher education.

This award salutes "non-traditional" students who deal not only with the usual challenges of college studies, but also juggle home, family and work responsibilities. There isn't much time for the usual college experience, yet they are enthusiastic about learning and have a wealth of personal expertise and strength which they gladly share to enhance the learning of others. These front runners illustrate the value of education because they have chosen to make sacrifices to pursue it, and in the process of becoming educated men and women, they have transformed their lives.

The 2019-20 John M. Grant Front Runner Awards are presented to Cynthia Tchorzynski and Jacob Braman.

Following are quotes from the nomination letters received from the students.

Cynthia Tchorzynski:

I was delighted and surprised to be selected for the John M. Grant Front Runner Award. I truly enjoyed my time at Alpena Community College while pursuing a degree.

I am a 1992 graduate of Atlanta High School. After high school I did not have any intentions of going to college. I had my diploma in one hand and my sevenmonth-old son in the other. I moved out of state for a short time but returned to Atlanta and was employed full time at a golf course. It was my employer who encouraged me to take classes at ACC. I began classes in the spring of 1998 with a goal of attaining a teaching degree. I completed three full time semesters earning forty credits. During this year and a half, I managed a full load of classes while working thirty hours a week along with a long commute between home and school. I still enjoyed my son in the evenings before he went to bed. His bedtime was the start of my study time. I was so focused on getting a degree and then the summer of 1999 I was offered a full-time job at Catholic Human Services. My delima was a degree or financial stability? I worked ten years and left the organization in 2011 with a small pension.

It was five years later while working at my current full-time job at LafargeHolcim that I decided to revisit my idea of getting a degree. I contacted the college and looked at my options. I was still able to apply my forty credits towards a degree. The time lost with my son, the late nights of studying and earning good grades was not done for nothing. I decided to take one or two classes a semester while working full time and raising my teenage daughter. I began in the fall of 2016 and completed in the summer of 2019 earning another twenty-five credits. A degree would not make me more money at my current job. The degree meant more to me than money. I went back to college the second time to complete what I thought I couldn't do. I did not earn a teaching degree but earned so much more. I earned self-respect for myself.

The staff and services at ACC helped me to grow as well as provide an educated life for myself. I have been a resident of Alpena since 2002 and raised two amazing children. My son resides in West Virginia with his wife of five years. They have blessed me with two grandchildren. My daughter will graduate this May with her associates as well. She has applied to the Physical Therapy Assistance program at Kellogg Community College. I began my path of attaining my degree with my son and will end it with my daughter. It's funny how life happens sometimes.

My interest while attending ACC were studying and being part of a misfit group that met at the Learning Center often. I utilized the wellness center to stay healthy. The support provided by so many at ACC allowed me to complete this degree and I am forever thankful. I have taken full advantage of all that Alpena offers. I've enjoyed many sunrises over the bay, hikes or cross-country skiing on the trails, bike rides all along the bike path, and events the downtown area offers. I spent many of hours in the gym or on the softball field coaching the youth. I am a member of St Paul Lutheran Church where I have taught Sunday school for five years.

I applaud all recipients of this award as we all know it takes an unusual person to make it happen. I can honestly say, that I enjoy seeing my Associate in Arts degree hanging on my wall.

Thank you for considering me for such a prestige's award.

Jacob Braman:

My name is Jacob Braman, and I am a non-traditional student in the Accounting Associate of Applied Science program at Alpena Community College. My college career has been quite lengthy and has seen many starts and stops along the way. Following the terror attacks on September 11th, 2001, I withdrew from college to join the U.S. Army, where I served for over five years as an Infantryman in the 101st Airborne Division. After my active duty obligation expired, I served in the U.S. Army Reserves as a Human Intelligence Collector for nine years until I was injured in my civilian job as a communications tower climber. The injuries I sustained rendered me unfit to continue my service in the U.S. Army Reserves and left me unable to perform the physically intense manual labor to which I was accustomed. Faced with the challenge of continuing to provide for my beautiful wife and our three children without a degree, I decided to re-enroll in college to complete my education.

My time at Alpena Community College was both challenging and deeply rewarding. Shortly after I began attending classes, my wife and I discovered that we were pregnant with our fourth child. With a full-time course load and an infant son at home, my time and attention were in high demand. At three-weeks-old, our youngest son was diagnosed with pyloric stenosis and had to undergo emergency surgery. My ACC instructors at the time were very understanding of the need for my absence and made certain that I was able to keep up with the required coursework. When I returned to school, I served as Dr. Darga's office assistant and I tutored my fellow students in Algebra, Microsoft Office Applications, Accounting, and Quickbooks. My involvement as an educational assistant waned when I was hired as an intern with a local accounting firm and began attending Northwood University classes as a part of the 3 + 1 arrangement with ACC, but my commitment to finally earning my degree never wavered. I am honored beyond words to have been nominated for the John M. Grant Front Runner Award, and I am thankful for the truly enriching experience my education at ACC has provided. I realize that the challenges I faced in earning my degree are similar to those that many non-traditional students must endure, but I greatly appreciate this opportunity to share a bit of my story.

Thank you for your time and attention in coordinating the nomination process for this award. I hope this synopsis is sufficient to aid in the selection process.

2.769 Anna and Jesse Besser Awards

Kennedy Chmura

2.770 Bids for the Purchase of Videoconferencing Equipment

In November 2016 the Alpena Community College Board of Trustees approved the purchase of a Cisco MX700 video conferencing system (VCS) to replace the College's outdated ITV equipment. One of the uses for the new equipment was to expand dual enrollment offerings for high school students and combine low enrollment sections at regional sites. At that time College officials noted that additional video conference equipment would eventually be needed as more regional high schools became interested in using the technology.

The COVID-19 pandemic in March of 2020 has shown the value of the VCS equipment, which has allowed the College to offer quality remote learning courses while face-to-face courses are restricted. This capability was essential to finishing Spring Semester and will also play a major role in course offering for Fall Semester.

In February 2020 the Board of Trustees approved a purchase of 18 additional Cisco delivery systems to fulfill the requirements of the USDA Distance Learning and Telemedicine grant. That equipment has been partially distributed to partner organizations and is not available for general College use.

ACC officials have determined that more VCS units could be utilized in classrooms on the Alpena and Oscoda campuses to provide more remote learning opportunities. The VCS equipment previously purchased is now being fully utilized and new schools may express interest in using the system to deliver dual enrollment classes. To meet this anticipated need, College officials are proposing to purchase more video conferencing systems.

In May 2020 College officials solicited bids for 30 delivery systems. The RFP was sent to five vendors with two vendors responding with bids. Following are the results.

College officials propose to use CARES Act money to fund the full cost of the new equipment purchase. This equipment will be installed in Alpena Campus classrooms to facilitate the delivery of VCS remote courses.

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves the purchase of 30 CISCO videoconferencing delivery systems to be installed in Alpena Campus classrooms for a cost not to exceed \$170,660.70. Funding for the purchase will come from money received through the CARES Act.

2.771 Van Lare Hall Roofing Bids

Recent reviews of the condition of the current roof membrane covering Van Lare Hall indicate there are approximately 3-5 years of useful life remaining. Consequently, the College feels it is necessary to replace the entire roof membrane during the Capital Outlay renovation of Van Lare Hall. However, since this is beyond the scope of the original Capital Outlay proposal, the Department of Technology, Management and Budget officials have been clear that the additional costs of replacing the entire roof must be borne by the College separate from the project funds. The state-funded portion of the roofing project will stay within the scope of the original Capital Outlay approval and the additional amount would be funded from the College's Maintenance and Replacement Fund.

Spence Brother Construction worked with ACC staff to develop a roofing bid category to define the state-funded portion and the College-funded portion of the roof replacement. The bid request was publicly advertised in a variety of public plan rooms and commercial construction publications. Qualified local contractors were also contacted directly.

In keeping with the College's desire to proceed with complete roof replacement and have a single roofing contractor involved with both projects, it is recommended that the contract award be issued to the low bidder of the combined scopes, Great Lakes Roofing & Insulation Systems, Inc.

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves a contract with Great Lakes Roofing & Insulation Systems, Inc., to replace the entire Van Lare Hall roof membrane at a cost not to exceed \$292,500.00.

2.772 Bids for Chassis Dynamometer

Alpena Community College representatives recently distributed a Request for Proposals for a chassis dynamometer to be used by Instructor Dustin Ruehle and the Auto Service Program as part of the curriculum. The RFP had the following specifications:

- Inertia Chassis 2WD Dynamometer with Dynamic Vehicle Loading
- Minimum 1500 HP rated
- Above Ground with Ramps
- Training and Setup Included
- Axle Weight: At least 6,000 lbs.

The College has received two bids for the chassis dynamometer. They are as follows:

College officials have reviewed the bids and are proposing to accept the bid from Mustang Dynamometer for a price not to exceed \$34,955.00. The funding for this purchase would come from the program's auxiliary fund account.

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves the purchase of a chassis dynamometer from Mustang Dynamometer of Twinsburg, OH, for a cost not to exceed \$34,955.00. Funding for the purchase will come from the Auto Service program auxiliary fund account.

3.994 Financial Report

Monthly General Fund Revenue and Expense through April 2020 (Year to Year Actual Comparison)

- The property tax receipts of \$2,661,139 are \$39,412 more than those for April 2019. This is expected for this time of year.
- Tuition/fee receipts of \$6,152,723 are \$200,432 more primarily due to higher than expected enrollments and an increase in tuition rates.
- State aid for the current year is \$3,875,875, as expected.
- Instruction is more than last year due to scheduled payroll increases.
- OIT is up due to a significant increase in software maintenance costs and timing of information processing costs.
- Instruction Support is up due to salary and fringe benefit increases and timing of payout for retirees.
- Student services costs are more due to scholarships being up more than \$13,000, retirement payout, and a shifting of clerical responsibilities from word processing.
- Institutional administration is as expected.
- Physical plant is up due to the addition of the Alpena police presence on campus of \$42,500 and scheduled payroll increases combined with lower snow removal costs and reduced overtime and substitute wages.
- Net income through the tenth month of the fiscal year shows a gain of \$672,808, which is typical for this time of year.

Monthly General Fund Revenue and Expense through April 2020 (Budget to Actual Comparison)

- Various budgeted expenditures are lower due to restricted access to the buildings.
- Library books and equipment change is caused by the sizable increase in software cost in information processing of \$18,000.
- Transfers shows a \$14,241 expenditure as part of the required 15% match required of the USDA grant of \$500,000. A total of \$75,000 of transfers are expected by the end of FY 2021.
- All other categories are in acceptable ranges for this stage of the year.

General Fund Month to Month Comparison through April 2020

- There were three payrolls processed in August and January and payments were made for adjunct instructors, ESP II longevity and cash-in-lieu of health insurance in September and faculty overload, extra pays were paid in October and February, and mileage paid in December.
- All other Month-to-Month comparisons are tracking as expected.
