#### **Student Report**

Cross Country Coach Mark Jacobs introduced members of the 2020 Cross Country team and noted the diversity of the runners; among them were non-traditional students (including the first

female runner in four years) and international students. Jacobs predicted the team would earn Academic All-American status for the sixth year in a row.

## **Faculty Report**

Departing Vice President of Instruction Debbie Bayer addressed the trustees and thanked them for their dedication to the College and their support for ACC faculty and administrators.

Instructor Tim Kuehnlein gave an overview of how the College's overflow rooms system worked. He explained that approximately half of the students in his sections gather in a separate classroom which features VCS equipment so that social distancing can be achieved. Through the VSC equipment, student can interact with the instructor and other students in real time. Kuehnlein went on to say that many students have expressed to him that they prefer in-person instruction and appreciate the opportunity to take ACC courses face to face.

## **President's Report**

President's Report to the ACC Board of Trustees September 17, 2020

## Fall Semester Enrollment Official Count

Fall semester enrollment finished down 4.1% in headcount and 6.8% in credit hours compared to fall semester 2019. Enrollment highlights include:

- Online course enrollment was up 148.9% in credit hours, and 102.1% in headcount.
- Early College enrollment was up 28.9% in credit hours, 23.5% in headcount.
- Dual enrollment was up 15.9% in credit hours, 3.8% in headcount.
- Early College and dual enrollment were responsible for 40.76% of headcount and 28.92% of credit hours.
- Continuing Students and New First Time Students, the largest aggregation of headcount and credit hours, were both down more than 15 percent in credit hours.

ACC finished third among Michigan's 28 community colleges in headcount based on data from the Michigan Community College Student Services Association (MCCSSA), the official report from community college registrars.

#### Vice President of Instruction

Steven Fosgard is the new Vice President of Instruction at Alpena Community College.

Steve was Dean of Occupational Programs at Kirtland Community College. His work in higher education has encompassed responsibilities as a faculty member and an administrator. He also has experience working in the private sector in the manufacturing field. He has won several Higher Education awards including the 2014 MACET Special Projects Award, the 2010 Educator of the Year for Collaborative Teams from TRENDS, and was a co-recipient of the 2008 League of Innovation Award for Alternative Energy Curriculum.

Steve has been involved in numerous college and community committees, new initiatives, program management, course development, and developing articulation and transfer agreements with secondary schools and universities. The majority of his career has been focused on enhancing student success with emphases on student-centered learning, delivery methodologies, assessment, student engagement, and service learning. Additionally, he has been heavily involved in grant writing and management (including Perkins, National Science Foundation, and the Lumina Foundation); institutional budgeting, strategic and operational planning; facilities management; accreditation, institutional effectiveness, class scheduling, and conflict resolution; and off-campus and university center management.

## **Futures for Frontliners**

Alpena Community College announced that it will serve as a Frontliners Champion to support the Futures for Frontliners program unveiled last week by Governor Gretchen Whitmer. Futures for Frontliners offers Michiganders who worked in essential industries during the April 1-June 30 period but do not have a college degree free "last-dollar" tuition to their local community college to pursue an associate degree or a skills certificate on a full-time or part-time basis while they continue to work. According to MCCA President Mike Hansen, the Frontliners website received 170,000 hits statewide in the first 48 hours, demonstrating a remarkable level of interest in the program across Michigan. According to state officials, the Frontliners program will be available spring semester. Program eligibility will be determined by state officials from Labor and Economic Opportunity (LEO), a process initiated by visiting the LEO website and clicking on the Frontliners link. ACC's point of contact for the program is Amanda Sumerix.

#### 21 Day Equity Challenge

Next week ACC will be implementing the 21-Day Equity Challenge, an interactive digital resource for individuals to deepen their understanding of racism. For 21 days, participants will receive an email "prompt" with a short reading, video or audio file. Participants are encouraged to take ten to fifteen minutes each day with the material in the prompt, though extra resources are provided in case they want to dig further into the day's topic. #### **Financial Report**

Vice President for Administration and Finance Richard Sutherland shared an update on the College's PPP loan situation: the College had incurred the full amount allowed by the loan for payroll and fringe benefits and had applied for loan forgiveness. He is waiting on the application to be processed by the bank, which could take up to 60 days.

Sutherland also noted that the state could allow community colleges to claim budget losses due to decreased enrollments as part of the state's funding formula for Fiscal Year 2021.
