2.782 Bids for Purchase of Anatomage Anatomy Visualization System

In 2019 Alpena Community College received a \$2.25 million Strengthening Institutions Program (SIP) grant from the U.S. Department of Education. One of the tracks within this grant relates to enhancing teaching technology in the Nursing Program.

To accomplish this part of the grant, ACC officials created a request for proposals (RFP) seeking vendors to submit bids for an anatomy visualization system.

The Anatomage Table, made by Anatomage, is the only piece of equipment that exists with the specifications desired by ACC. College officials have determined that Anatomage is the only vendor that offers the product. In order to ensure no other comparable product(s) existed an online search was conducted for other companies who may offer a similar product. Only one company, Taiwan Main Orthopaedic Biotechnology, offers a similar product, but they are located in China. Due to Anatomage being the only manufacturer and distributor of this product in the United States, a representative of the U.S. Department of Education approved the purchase to be made through non-competitive bid and purchasing directly through Anatomage in accordance with 34 CFR §607.10(b)(4).

According to Anatomage:

"The Anatomage Table is the most technologically advanced 3D anatomy visualization system on the market. It is both a virtual library of human and animal cadavers, as well as a clinical diagnostic tool by visualization of any Medical CT, CBCT or MRI scan. The operating table form factor combined with Anatomage's renowned radiology software and clinical content separates the Anatomage Table from any other imaging system on the market."

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves the purchase of one Anatomage Table from Anatomage at a cost not to exceed \$89,809.00. All purchases shall be made from SIP grant funds.

2.783 Bids for Career Exploration Software

Another track in the 2019 Strengthening Institutions Program (SIP) grant from the U.S. Department of Education relates to enhancing ACC's Student Services and associated activities. As part of those activities the grant proposed to purchase career exploration software for students to use, either in conjunction with a Student Support Services technician or by themselves. Specifically, the software allows for the following tasks:

- Career Exploration
- Career Assessment
- Strengths Summary and Career Match
- Career Job Descriptions
- Resume Building
- Careers to Programs
- Local Labor Market Data
- Analytics
- Employer Portal or Work Opportunities

Additionally, the software will assist students in not only which career best suits them, but also which program at ACC best suits them, as the software will link directly to ACC's programs.

ACC officials created a request for proposals (RFP) seeking vendors to submit bids for career exploration software to be used by both the Student Success Center and students. The software should be web-based and embedded into ACC's webpage in order to facilitate a seamless, user-friendly integration for Student Support Services staff and students to learn and utilize. The purchase is to be funded 100% by the SIP grant.

The RFP was sent to three comparable software vendors: Emsi, Focus 2 Career, and Starfish. The vendors were all invited to an Optional Bidders' Conference Call, which provided for consistency and clarity of answers to questions. None of the three vendors called in during the Optional Bidders' Conference Call. A representative from Starfish sent an email declining their participation in the bid process, due to their software programs encompassing more than just career exploration. On September 4, one proposal was received from Emsi. There were no other proposals received.

During the review process, Emsi's Career Coach software was determined to meet all specifications from the RFP and would meet the needs of ACC's Student Support Services. Additionally, Career Coach was recognized as a well-known software, with unlimited individual and group training for the Student Support Services staff.

Based on the evaluation process, ACC officials are recommending ACC enter into a three-year subscription for Emsi's Career Coach software. The first year of the subscription would cost \$9,500.

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves the purchase of a three-year subscription of Emsi's Career Coach, a career exploration software solution at a cost not to exceed \$9,500 per year for three years. All purchases shall be made from SIP grant funds.

4.003 Financial Report

Monthly General Fund Revenue and Expense through August 2020 (Year to Year Actual Comparison)

- The property tax receipts of \$531,146 are \$24,402 more than those for August 2019, as expected.
- Tuition/fee receipts of \$3,268,465 are \$46,908 less primarily due to lower than expected enrollments.
- State aid for the current year is only \$5,355 because of the normal start of payments in the month of October.
- The entire \$2,435,600 in Paycheck Protection Program funding is recorded through August. The College is in the process of applying for the forgiveness portion of the program.
- A number of cost centers are lower because of delays in receiving invoices.
- Net income through the second month of the year shows as a gain of \$3,704,857, which is typical for this time of year, when fall tuition receipts have built up and combined with the PPP funds recorded.
