2.793 Election of Board Officers

The election of officers of the Alpena Community College Board of Trustees usually occurs biennially in the month of January following a general election in which trustee seats are up for election. Board officers thereby serve two-year terms of office as specified by the official by-laws of the Board.

The last officer election was held at the January 16, 2019, Board of Trustees meeting. A general election was held on November 3, 2020; two trustee seats were up for election.

The	erefore, the following resolution is proposed:
a)	The Board of Trustees approves the election of as Chairperson of the Board of Trustees;
b)	The Board of Trustees approves the election of as Vice Chairperson of the Board of Trustees;
c)	The Board of Trustees approves the election of as Treasurer of the Board of Trustees;

d) The Board of Trustees approves the appointment of Denis J. Walterreit as Secretary of the Board of Trustees.

The term of office for all officers will extend through December 31, 2022, unless changed by official resolution of the Board of Trustees.

2.794 USDA Grant Purchase: Medicine Dispenser and Telemedicine Carts and Cameras

Alpena Community College was awarded a United States Department of Agriculture, Rural Utility Service, Distance Learning and Telemedicine (DLT) grant in August of 2019. The purpose of the equipment-only grant is to outfit area K-12s, health care organizations, and the College with the most up-to-date equipment to deliver distance learning, opioid prevention and education, and STEM/healthcare related content to students, residents, and the workforce.

Thus far, the DLT grant has funded the purchase of 27 Cisco videoconferencing systems and five remote learning systems for Nursing classrooms. The next proposed grant purchase involves two highly technical pieces of equipment for use in the Nursing labs: a medicine dispenser training system and telemedicine carts with camera systems and accessories.

Requests for Proposal (RFP) for two USDA-approved pieces of equipment were distributed to vendors on December 10, 2020, with responses due to ACC prior to noon on January 8, 2021. Results were competitive, bidder's conferences were well attended, and subsequent bids were thorough.

The selection committee of Dawn Stone, Dean of Workforce Development, Melissa Fournier, Director of Nursing, and Terry McKenzie, Simulation Lab Manager, met on January 14, 2021, to read through each proposal and score them based on the scoring matrix provided in the RFP. The chosen bidders were unanimously agreed upon by the selection committee.

Specifications for the medicine dispenser training system are as follows:

• Unit

- o Automated medication dispensing system
- o Must include all appropriate accessories for training of medical staff
- Locking lid/drawers
- o Able to expand or modify as needed
- o Integration with electronic health record systems
- o Barcode scanner
- o Printer

• Integrated Technology

- o Fully automatic and independent
- o Interoperate with adjacent systems
- Able to produce analytics/data intelligence
- o Cloud-based
- o Include all hardware and software requirements

Two bidders, Medical Shipment LLC (Skokie, Illinois), and iMedTac (Taipei City, Taiwan), submitted bids which were evaluated. Based on the evaluation process, Medical Shipment LLC was deemed the successful bidder. The total amount of Medical Shipment LLC's bid was \$45,998.00.

Specifications for the telemedicine carts, cameras, and accessories are as follows:

- Units
 - o Three (3) telemedicine carts
 - o Must be FDA Class One Registered Medical Device
 - o Integrated storage
 - o Effective audio and video capabilities
 - o Able to send and receive calls
- Cameras/Accessories
 - o Two (2) Horusscope 3 cameras
 - o Two (2) Thinklab stethoscope with IO
 - o Two (2) Fundus opthalomoscope lenses
 - o Two (2) Dental lens for Horusscope
 - o Two (2) Fundus anterior chamber lens
 - o Two (2) Cardionics E-Scope electronic stethoscope with 3.5 mm stereo plug

Four bidders submitted bids which were evaluated: AMD Global Telemedicine, Inc. (Chelmsford, Michigan), GlobalMed (Scottsdale, Arizona), CDW/Amwell (Boston, Massachusetts), and AFC Industries (College Point, New York). Based on the evaluation process, CDW/Amwell of Boston, Massachusetts, was deemed the successful bidder. The total amount of CDW/Amwell's bid was \$102,328.00.

The USDA DLT Grant will reimburse the College for 85% of approved equipment for use in ACC's Nursing Program and the newly-renovated Van Lare Hall, when completed.

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves the purchase of a medicine dispenser training system from Medical Shipment LLC of Skokie, Illinois, for an amount not to exceed \$45,998, and the purchase of telemedicine carts, cameras, and accessories from CDW/Amwell of Boston, Massachusetts, for an amount not to exceed \$102,328.00. The cost of these purchases will be 85% reimbursed by the USDA DLT grant.

4.013 Financial Report

Monthly General Fund Revenue and Expense through December 2020 (Year to Year Actual Comparison)

- The property tax receipts of \$871,657 are \$100,778 more than those for December 2019, higher due to timing of receipts.
- Tuition/fee receipts of \$5,509,401 are \$296,159 less primarily due to lower than expected enrollments for Spring registrations.
- State aid is as expected.
- Federal revenue displays the entire \$2,435,600 in Paycheck Protection Program funding as recorded through December. The College has applied for the forgiveness portion of the program and awaiting determination.
- There were three payrolls processed in December causing each area to be higher than last year.
- Instructional support is as expected for this time of year.
- Student services is as expected for this time of year.
- Institutional Administration is higher due to significant legal fees related to the adjustments made to the Title IX policies and procedures over the past six months.
- Physical plant is as expected for this time of year.
- All other expense areas are as expected for this time of year.
- Net income through the sixth month of the year shows as a gain of \$3,135,786, due to PPP funds recorded, reduced by lower than anticipated tuition revenue.

Monthly General Fund Revenue and Expense through December 2020 (Budget to Actual Comparison)

- Travel is down compared to last year due to COVID 19 travel restrictions.
- Library Books & Equipment is down based on timing of acquisitions.
- All expense categories are in acceptable ranges for this stage of the year.

General Fund Month to Month Comparison through December 2020

- December property taxes were higher due to the receipt of winter taxes.
- There were three payrolls in December of this year and three payrolls in January of last year.
- All other Month-to-Month comparisons are tracking as expected.

Consolidated Income Statement for the first quarter of FY 2021

- The balance in Restricted Funds represents remaining revenue for the New Jobs Training Program.
- The deficit in Plant is due to using previously recorded funding from last year for Van Lare Hall project. The College will start transferring funds from the Foundation in the next couple of months.
- The remaining balances are reasonable for this time of year.
