### 2.800 Bids for TRiO Talent Search Gaming Laptops

As part of Alpena Community College's TRiO Talent Search grant requirements, Talent Search provides annual educational summer camps to program participants. The grant currently requires the curriculum address STEAM (Science, Technology, Engineering, Art, Math), with priority given to computer science. The Department of Education identifies computer science as coursework through hands-on learning opportunities such as software development, programming, graphics, coding, game development, etc.

For the upcoming year, TRiO Talent Search has identified the need for 10 gaming laptop computers to be used for instruction during summer camp. The laptops will be used by TRiO participants during a 5-day camp, where they will be led by an instructor from ID Camp. During the camp, participants will be immersed in learning the fundamentals of game design through the development and planning of game maps, character creation, Java coding, using programming logic and animation, with the end result of creating and publishing a game on the site platform.

TRiO Talent Search staff worked with the Office of Information Technology to develop a Request for Pricing for 10 laptops.

TRiO Talent Search and ACC officials evaluated the quotes and recommend the Lenovo Thinkpad P17 equipment because the lowest priced equipment did not meet specifications.

### Therefore, the following resolution is proposed:

The Board of Trustees approves the purchase of ten (10) Lenovo ThinkPad P17 Gen 1, 17.3" laptop computers from CDW-G for a cost of not more than \$20,250.00. This purchase would be made using TRiO Talent Search funds.

### 2.801 Bids for a Vehicle Lift System

Alpena Community College regularly updates equipment used for instruction by academic programs. Funding for these purchases comes from a variety of sources including Perkins grants, other state and federal grants, and a variety of ACC funds.

The Automotive Service program is in the process of gathering bids to purchase a pneumatic vehicle lift system to replace the aging system currently in use in the Auto Service lab. ACC officials have solicited bids for a new system and are currently gathering the information needed to present a proposal to the Alpena Community College Board of Trustees. Since the purchase would be at least partially funded by Perkins funds, the purchase and delivery of the equipment would need to happen before the end of ACC's fiscal year in June.

Final bid information was not available at the time this Board meeting agenda was distributed. ACC officials will finalize a proposal and distribute it to the trustees as soon as possible prior to the April 15 meeting so that trustees have time to evaluate the action item.

### 4.022 Financial Report

Monthly General Fund Revenue and Expense through March 2021 (Year to Year Actual Comparison)

- The property tax receipts of \$2,734,044 are \$232,438 more than those for March 2020, higher due to timing of receipts.
- Tuition/fee receipts of \$5,857,718 are \$220,771 less primarily due to lower than expected enrollments for Spring registrations.
- State aid is as expected.
- Federal revenue displays the entire \$2,435,600 in Paycheck Protection Program funding as recorded through March. The College has applied for the forgiveness portion of the program and awaiting determination.
- Instruction and Instructional Support are as expected for this time of year.
- Student services is as expected for this time of year due to the changeover in registrar from last year.
- Institutional Administration is higher as expected due to the addition of the Alumni Relations position, and changes in healthcare coverage.
- Physical plant is lower due to timing of payment to Alpena Police Department and, lower overtime.
- All other expense areas are as expected for this time of year.
- Net income through the ninth month of the year shows as a gain of \$3,256,711, due to PPP funds recorded, reduced by lower than anticipated tuition and fee revenue.

Monthly General Fund Revenue and Expense through March 2021 (Budget to Actual Comparison)

- Supplies are lower due to the lower number of students and staff on campus.
- Energy costs are higher due to timing of utility bill payments.
- Travel is down compared to last year due to COVID 19 travel restrictions.
- Library Books & Equipment is down based on timing of acquisitions.
- Other expenses are higher due to higher usage of credit card payment and higher debt write-offs.
- All expense categories are in acceptable ranges for this stage of the year.

General Fund Month to Month Comparison through March 2021

- March property taxes were higher due to the timing of winter tax receipts.
- All other Month-to-Month comparisons are tracking as expected.

Consolidated Income Statement for the third quarter of FY 2021

- The negative balance in Endowment and Scholarship Restricted Funds represents a delay in receiving funds.
- The deficit in Plant is due to using previously recorded funding from last year for Van Lare Hall project. The College will start transferring funds from the State in the next several months.
- The remaining balances are reasonable for this time of year.
