### 2.825 Bids: Classroom Chairs

Alpena Community College solicited bids for 581 replacement classroom chairs. The current classroom chairs in the Besser Technical Center, Natural Resources Center, and World Center for Concrete Technology were purchased in the late 1990s and have reached the end of their usable life.

The chair style was chosen to be easier to clean and disinfect. These features will save work time and also enable the College to utilize HERFF money to pay for the purchase.

Vendors were selected through a public advertisement and bidding process during the Van Lare Hall renovation project. In order to provide the greatest flexibility for the placement of furniture, and to ensure consistency between buildings, these additional chairs will match those that were purchased for the Van Lare Hall project as well as the chairs that are currently in the Newport Center.

Two bids were received for the 581 replacement chairs:

College officials have evaluated the bids and determined the low bid from Custer, Inc., meets the specifications.

#### Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves the bid from Custer Inc., of Traverse City, Michigan, for \$82,504 for the purchase of 581 replacement classroom chairs for use in Besser Technical Center, the Natural Resources Center, and the World Center for Concrete Technology.

### 2.826 Bids: Snow Plowing and Removal

The College periodically requires snow plowing and removal throughout the winter season to ensure that students, employees, and visitors can move around the campuses safely. Pinning down a specific cost for the service is impossible due to the unpredictable nature of snowfall in Northeast Lower Michigan.

The College solicited bids for 2021-22 snow removal for the Alpena Campus by placing an ad in *The Alpena News*. No responses were received.

College officials then contacted last year's vendor, Morgan Forest Products, to solicit their interest in providing snow plowing and removal services. The vendor proposed a contract which specified an hourly snow plowing rate of \$65 and an hourly snow removal rate of \$100 with a minimum fee of \$20,000 for the year.

College officials have evaluated the proposal and recommend it for approval.

### Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees approves a contract with Morgan Forest Products of Alpena, Michigan, for snow plowing and removal for the 2021-22 year. The hourly rate for snow plowing will be \$65; the hourly rate for snow removal will be \$100. The minimum fee for the year will be \$20,000.

# 4.037 Financial Report

Monthly General Fund Revenue and Expense through October 2021 (Year to Year Actual Comparison)

- The property tax receipts of \$585,123 are \$32,367 more than those for October 2020, due to both unexpected and expected increases.
- Tuition/fee receipts of \$3,448,694 are \$19,689 higher primarily due to faster early college enrollments.
- State aid for the current year is \$846,231. This includes a regular monthly payment of \$530,070, plus \$225,700 as a one-time appropriation payment and a semiannual personal property tax payment of \$90,461. This is the first payment of the year.
- The difference in Federal is due to \$2,435,600 in Paycheck Protection Program funding recorded through September of 2020. The College did not budget nor expect any of those kinds of revenues in FY 2022.
- The General Fund received \$323,123 for lost tuition and fee revenue through Federal HEERF funds.
- There were three payrolls processed in July for both FY 21 and FY 22.
- There is an overall increase in wage and fringe benefits of about 3% this year
- Physical Plant is as expected for this time of year.
- Net income through the fourth month of the year shows a gain of \$158,291.

Monthly General Fund Revenue and Expense through October 2021 (Budget to Actual Comparison)

• All categories are in acceptable ranges for this stage of the year except as noted above.

General Fund Month to Month Comparison through October 2021

- Contract services in July includes the annual maintenance contract with Ellucian for about \$173,000.
- Salaries and fringe benefits were higher due to full-time faculty overload pay and department chair stipends.
- Outside services jumped due to annual elevator maintenance of \$14,988 and \$16,105 of audit fees charged.
- Insurance payments are paid irregularly.
- Other includes bank fees as part of the use of credit cards for tuition and fee charges.
- All other Month-to-Month comparisons are tracking as expected except as noted above.
