The Alpena Community College Board of Trustees and the Alpena Community College Foundation Board gathered at 8:30 a.m. for a continental breakfast and informal conversation. The workshop began at 9:00 a.m. with ACC Board of Trustees Chair John Briggs calling the meeting to order.

Chair Briggs then delivered his opening remarks, followed by ACC Foundation President Sue Fitzpatrick and ACC President Dr. Don MacMaster. Consultant Kathleen Guy, co-founder of the Eaton Cummings Group, then took over leadership of the meeting and shared the workshop goals and an outline of the agenda. Participants were broken into four groups and participated in a variety of activities including:
