2.884 Bids: Security Guard Services for the Alpena Campus

In October 2018 the Board of Trustees approved a contract with the City of Alpena and the Alpena Police Department to provide enhanced law enforcement coverage for the Alpena Campus for the period of January 1, 2019, to December 31, 2024. That agreement provided a certified police officer to the Alpena Campus for general coverage as well as attending Board of Trustees meetings and other College activities.

Changes in Alpena Police Department staffing have impacted the availability of an officer to be present on the Alpena Campus for regular activities. Officers continue to attend ACC board meetings. The shortage of officers is forecasted to last through the 2023-24 ACC school year.

In an effort to augment the contract with Alpena Police Department, ACC officials circulated a Request for Proposals (RFP) for security services for the Alpena Campus. The RFP was published in *The Alpena News*.

One business responded to the RFP. Allied Universal of Conshohocken, PA, provides physical security, technology security, risk advising and consulting, executive protection and intelligence services, and security/safety training and currently employs nearly 300,000 security professionals protecting over 50,000 client sites.

Allied Universal submitted a bid with a total price of \$73,222.40, which includes Allied Universal supplying its own vehicle, gasoline being billed as expenses are incurred, and a cell phone.

College officials have reviewed the bid information and continue to negotiate with Allied Universal to refine the services to be provided. To expedite the process of hiring Allied Universal, College officials are asking the Board of Trustees to approve the bid at a cost not to exceed the amount listed above.

Funding for the new security services would come from the General Fund.

Therefore, the following resolution is proposed:

The Alpena Community College Board of Trustees authorizes College officials to contract with Allied Universal of Conshohocken, PA, for security services for a cost not to exceed \$73,222.40.

4.091 Financial Report

Monthly General Fund Revenue and Expense through July 2023 (Year to Year Actual Comparison)

- The property tax receipts of \$152,574 are \$35,692 less than those for July 2022, due to timing of receipts.
- Tuition/fee receipts of \$3,149,811 are \$353,160 more primarily due to higher-than-expected registrations at this time of year.
- State aid for the current year is zero because of the normal start month of October.
- There were only two payrolls processed in July for FY 24 and three payrolls for July FY 24.
- Net income through the first month of the new fiscal year shows as a gain of \$2,179,925, which is typical for this time of year, when fall tuition receipts have built up.

Monthly General Fund Revenue and Expense through July 2023 (Budget to Actual Comparison)

- All categories are in acceptable ranges for this stage of the year except as noted above.
