#### **Board Member and Subcommittee Reports**

Trustee Duncan noted the following points related to the ACC Foundation:

- The Office of Alumni Relations is seeking nominations for the Distinguished Graduate Award. Nominations are due March 31st. For more information, contact Mary Eagan, Director of Alumni Relations.
- The scholarship application deadline has been extended to March 31st. Due to a delay in receiving FAFSA information from the federal government, scholarship awarding will be delayed by a few months. We are hoping to get the needed information and begin making awards in May.

#### **Faculty Report**

Art Instructor Brian Schorn delivered a brief overview of activities in the Art Department over the last three years. He mentioned:

- The creation of a state-of-the-art digital design lab with Apple computers.
- New white exhibition panels were installed and are now being used.
- A new course, "Sound Art," will be offered soon.
- Art program enrollment has grown from approximately 20 students three years ago to approximately 70 this year.

#### Congressionally Directed Spending Awarded to ACC for Student Housing

Thanks to the support of U.S. Senator Gary Peters, ACC recently received a \$1.75 million Congressionally Directed Spending appropriation in the FY24 federal budget to add 32 more beds of on-campus student housing. The appropriation will run through the United States Department of Agriculture, Rural Development, Community Facilities account and will require College compliance with all program stipulations mandated by that agency. A detailed cost estimate for adding another 32 beds to the 64 beds ACC currently owns and manages is \$4.7 million with a projected 10-month construction cycle. College staff is actively seeking the remainder of the funding through a combination of State appropriation, existing College resources, and potential ACC Foundation fundraising support. Thanks

again to Senator Peters for his ongoing support of ACC and the entire Alpena region. His advocacy continues to makes a difference.

## Besser Tech Center Boilers Require Attention

Currently the Besser Tech Center boiler room supplies hot water to heat both the Besser Tech Center and the Newport Center buildings. Most of the pumping system is from the early 1960s and the three Fulton Pulse Boilers were installed in 2007. Since early January, we have had one of the three boilers shut down and isolated due to mechanical failure and found that it's ultimately non-repairable. We have been running with two boilers and have experienced periodic failures which have caused disruptions to campus operations. We also have data telling us that a second boiler could be near failure which leaves us vulnerable and motivates the need to address the Besser Tech boiler situation as we enter summer break. Facilities director Kurt Konieczny and Dr. Nick Brege, Vice-President for Administrative Services, are here to discuss the situation in more detail.

### **Financial Report**

Monthly General Fund Revenue and Expense through February 2024 (Year to Year Actual Comparison)

• The property tax receipts of \$2,564,306 are \$215,013 more than those for February 2023. Much of the positive variance from last year was expected as property tax revenue was budgeted to increase this year. However, a portion of the variance is due to receiving some payments earlier compared to this time last year.

- Tuition/fee receipts of \$6,548,323 are \$670,039 more than last year largely due to higherthan-expected billable contact hours.
- State aid for the current year is \$3,185,220 and is \$263,335 more than last year as expected.
- Interest income is derived from the significant cash balances swept into money market accounts. The increase from last year is due to changing the way the College invests those funds. We are now taking full advantage of the higher rates available.
- Other revenue is \$93,108 higher than last year primarily due to the timing of the ADN to BSN Completion grant transfer.
- OIT is higher due to the annual Ellucian software cost expensed.
- Institutional Administration is significantly higher primarily due to legal fees (\$75,000), timing of advertising costs (\$42,000) and changes in fringe benefit selections (\$31,000).
- Net income through the first eight months of the fiscal year shows a gain of \$1,431,948, which is typical for this time of year.

Monthly General Fund Revenue and Expense through February 2024 (Budget to Actual Comparison)

- Outside Services are higher due to the Ellucian software expense and because of changes in legal and advertising fees as noted above.
- Supplies are much higher due to purchasing nursing student books/supplies packages through nursing instructional supplies and receiving for those supplies through course fees.
- All categories are in acceptable ranges for this stage of the year except as noted above.
