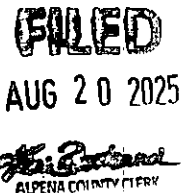
**ORDER GRANTING PETITIONER'S  
MOTION TO MODIFY PERSONAL PROTECTION ORDER AND  
AWARDING ATTORNEY'S FEES AND COSTS TO PETITIONER**

At a session of court held in the courthouse

Present: Hon. K. Edward Black, 26<sup>th</sup> Circuit Court Chief Judge

This matter having come for hearing on Plaintiff's Motion to Modify Personal Protection Order, and the parties having appeared in open court, and the Court having considered the evidence, testimony and arguments presented, and being otherwise duly advised in the premises, NOW THEREFORE THE COURT FINDS THAT:

1. Respondent engaged in sending mail to certain former named employees of Alpena Community College after being prohibited from doing so by the Personal Protection Order, in violation of the specific terms of the Personal Protection Order.



2. Respondent used the name "April Tosch" in these mailings without her knowledge or consent,

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

1. Petitioner's Motion to Modify the Second Amended Personal Protection Order dated April 7, 2025, is granted.
2. The Court shall enter a 3rd Amended Personal Protection Order, a copy of which is attached hereto, expressly stating that Respondent is prohibited from engaging, either directly or indirectly, in any of the prohibited contact specified in the Personal Protection Order. Indirect prohibited contact shall include the use of proxy, agent or other third-party acting on behalf of Respondent.
3. Respondent is also prohibited from engaging in such prohibited contact under a fictitious name or through the use of the name of another person. Respondent shall pay the sum of One Thousand Dollars (\$1000.00) to the Petitioner, for attorney fees and costs. The failure to pay such amount shall constitute a further violation of the Personal Protection Order, as amended.
4. If Respondent continues to violate the Personal Protection Order, the court will assess a fine of at least \$250 per letter or other violation, and the Respondent will be subject to immediate arrest and the civil and criminal contempt powers of the court, which shall include imprisonment, pursuant to MCLA 600.2950a
